	 Meet the Candidates for the National Elections: Ran an event in Bray to support community groups & individuals to meet the candidates running in the national elections and supported (and attended) 2 member groups to run similar events in their area
	 Meet Your Local Elected Representatives: Ran 5 Online events, 1 for each MD on Thursday evenings in October. 117 people from a broad spectrum of community groups engaged with the sessions and 28 of our 34 elected representatives answered over 80 diverse questions. A report from the meetings is available on our website
	 COVID-19 Significantly changed our 2020 work programme. Worked with WCC IT to identify the community response to the pandemic and map this for reference to support the community call.
	 Wicklow Community Response Forum (WCRF) – A WCC committee set up to coordinate the county response to the COVID-19 health crisis. Actively participated in fortnightly online meetings to highlight community issues/concerns as well as share information & supports
	 WCRF Digital Poverty Sub-Group: actively participated in this group which was set up to respond to issues being raised in relation to the digital divide. Supported the development of a WCC grant process to resource most affected groups.
	 WCRF Staying Connected & Managing Your Mood Sub-group: set up as part of the Keep Well Campaign to coordinate, communicate, publicise and support local initiatives set up to promote & facilitate community wellbeing & resilience in accordance with the national Keep Well – Growing Our Resilience Campaign.
	Social Inclusion Week: Facilitated network meetings to organise events to run in Social Inclusion Week 17 to 23 October in collaboration with various groups and organisations that work with a Social Inclusion Focus. Due to COVID-19 most of the events were cancelled. Work changed to raise awareness of Social Inclusion and highlight some of the initiatives that were taking place across local and online media
	Disability & Inclusion Work: Established and facilitated a working group for people and organisations working to promote disability access and awareness raising. The work of this group was integrated into the new WCC Disability Access & Inclusion Group in the 3 rd quarter of 2020
	 Sustainable Development Goals: Worked with WCC environmental officer to develop a mapping tool for community groups to link their actions to the SDGs
	 County Wicklow Integration Strategy: Participated in an interview with the consultant engaged to develop the strategy and networked her into other organisations including the Glencree Centre for Peace & Reconciliation.

Networking/ Working Regionally, & Nationally

- National PPN Conference: Preparation began to organise & run the event in the Arklow Bay Hotel in early October 2020. Due to COVID-19 the event was postponed and has been rescheduled for Nov. 2021
- Dept Public Expenditure & Reform: Participated in DEPR Interview Re Organisational Capability Review of the Dept. Rural & Community Development
- Irish Environmental Network: Presented at 2 Irish Environmental Network online seminars (approx. 70 people in attendance at each), highlighting Wicklow PPN work in developing our Vision for Community Wellbeing Statements, linking them to the Sustainable Development Goals and highlighting both in PPN submissions as well as ongoing collaboration with WCC to develop a mapping initiative to show how community groups are actively working towards the SDGs
- National Resource Workers Network: A peer support group for PPN
 Resource Workers. Attended 3 meetings and provided text, call, and email
 support to colleagues.
- National PPN Advisory Group: Oversight committee for PPNs. Participated in 4 meetings. Resource Worker was nominated to this group by the Resource Workers Network for a second 3-year term in November 2020. Also participated on the 2019 Annual Report sub-group & 2020/2021 Annual Conference Sub-group
- National Secretariat Network: A peer support group for PPN Secretariats.
 Each PPN has one seat on this group. Wicklow Rep attends quarterly meetings and participated at sub-group level.
- PPN User Guide/Handbook: A guide for PPN stakeholders on structures, policies, and procedures for PPNs. Actively participated in PPN User Guide Review, held consultation with Secretariat and Reps and made a submission. New PPN Handbook launched 19th November 2020 and is available on our website
- Regional Support Meetings for Working with Migrants: With support from Glencree Centre for Peace & Reconciliation, facilitated meetings for peer support in developing & implementing Local Integration Strategies and working with migrants. One meeting was for local authority & local development company staff (8 counties attended) and the second for PPN Resource Workers (9 counties attended).

PPN Meetings/ Specific Work

- Secretariat: The Secretariat continued to advise and support the Resource Worker & Support Worker, 8 meetings were held throughout the year along with Emails, texts and calls when further help was needed. We welcomed 4 new members to the Secretariat in 2020
- Liaison Sub-Group: A group consisting of 1 rep each from the Secretariat, the hosting organisation and WCC along with the Resource Worker. The group ensures that all local PPN Stakeholders are informed of the PPN's development & progress. 2 meetings held

- **HR Sub-Group:** A new sub-group of the Secretariat set up this year. Currently working on a Terms of Reference
- Co Wicklow Visions for Community Wellbeing: Continue to promote and use the consultation material and Vision Statements as the foundation for all our work and raise awareness of these resources at every opportunity.
- Sustainable Development Goals: Highlighted awareness of SDGs in all PPN submissions and clearly linked them to our Vision for Community Wellbeing. Worked with animator to develop an animation to raise awareness of the Sustainable Development Goals, show how SDGs link to Our Vision for Community Wellbeing, show how actions of member groups link to SDGs, and encourage groups to map their actions against the SDGs using the WCC mapping tool. Animation launched and circulated in December and available on PPN You Tube Channel and Website
- Keep Well Campaign/Community Wellbeing: Worked with Avril Bailey,
 Human Givens Counsellor & Coach to develop our Supercharge Your
 Selfcare Training Programme into 5 short videos that will support
 individuals and communities to look after themselves and each other. The
 videos clearly link to Our Visions for Community Wellbeing and the National
 & Local Keep Well Campaign. Videos launched and circulated in December

- PPN Representative Induction/Training: Held an induction and peer support online meeting for current, past, and new PPN Representatives as well as one to one support meetings
- PPN Stakeholder Training: Pilot programme funded by Dept. Rural & Community Development & Facilitated by Social Justice Ireland and Waterford IT. 10 online sessions, including 7 class lessons backed up by pre class learning using video presentations and reading resources. 5 PPNs, including Wicklow invited to enrol 5 participants each from a mix of PPN Stakeholder groups. Wicklow enrolled 1 staff member, 1 secretariat member, 2 PPN representatives & 2 elected councillors. Programme to be evaluated and rolled out across the country in 2021.
