Membership

Networking/Working Locally

- Encouraging Engagement with Local Decision Making: Circulated WCC and MD Meeting dates and agendas to encourage public engagement with local decision making throughout the year.
- **Co Wicklow Volunteer Awards**: Sponsored & presented the Ukrainian Response Special Project Award at the Co Wicklow Volunteer Awards 23rd Feb.
- **Disability & Inclusion Work:** Actively participated in the WCC Disability & Inclusion Steering Committee. Members of the group were invited to introduce the DISC, its work and the development of the Toolkit for Community Groups at the Community Catch Up Meetings. A Wicklow Disability Strategy was developed during the year and launched at an event during Social Inclusion Week. A new committee page for DISC has been added to the PPN website under the representation & committees tag.
- International Womens' Day: Collaborated with County Wicklow Partnership to run an
 event to celebrate International Women's Day 8 March. Over 75 women from diverse
 geographic and social communities discussed what community means to them. Wicklow
 PPN provided an update on what has happened since the community consultation held
 last year to develop a Vision for Community Wellbeing and feed into the Local Economic &
 Community Plan
- Attended the Women of Wicklow Social Inclusion Network, in collaboration with Glencree Welcomes Refugees & the Women form the Sheds in Ballyraine event in The Colour Club 21 Oct. Interesting & welcoming conversations took place with women from Rwanda, Bangladesh, Costa Rica, Afghanistan, Georgia, and Syria.
- Municipal District Meetings/Community Catch Ups: Arklow MD 19/4, Baltinglass MD 26/4., Bray MD 3/5, Greystones MD 10/5, and Wicklow MD 17/5. Meetings were held in collaboration with WCC to provide feedback on the Vision for Community Wellbeing/Local Economic Community Plan consultations held in 2022 and as part of the Dormant Accounts Funded Engagement Project Pilot. Information also provided about the Wicklow Disability & Inclusion Committee, Wicklow Age Friendly Programme, and Wicklow Volunteer Centre. Groups were also invited to provide information about themselves and their activities.
- Wicklow Age Friendly Programme: Introduced the Wicklow Age Friendly Coordinator, the programme, Strategy, and the Older People's Council at the Community Catch Up Meetings. Encouraging engagement with the Older People's Council.
- Climate Change & Biodiversity: Met with WCC Climate Action Officer to support the roll
 out of consultations on the Wicklow Climate Action Plan. Met with newly appointed WCC
 Community Climate Action Officer and the newly appointed Biodiversity Officer Also met
 Environmental Awareness Officer and Assistant EAO. Community Climate Action Officer
 provided information about the Community Climate Action Fund at the PPN's summer &
 winter members meeting.
- Social Inclusion Network Group (SING): As a direct result of the Dormant Accounts Funded Engagement Project work, a Social Inclusion Network Group has been formed as a subgroup of the Local Community Development Committee. This is also an action in the new Local Economic & Community Plan. The purpose of the network is to provide a forum for regular communication between marginalised communities/groups working with a social inclusion remit at local level and the local authority and other support agencies as well as providing an opportunity for networking amongst all member

organisations. It will also examine and discuss relevant plans and programmes and review their impact in the community as well as identifying and addressing any gaps/needs in service provision. The group met in July and October and will meet again in January 2024. More information on SING is available on the PPN website on the committees page.

- Public Sector Duty: PPN team attended a meeting to review the WCC Draft Assessment of Equality & Human Rights Issues for use in their ongoing implementation of the Public Sector Equality & Human Rights Duty
- Comhairle na nOg: Participated in the Wicklow Comhairle na nOg Steering Committee
 Meetings. Wicklow Comhairle Coordinator presented the Youth Participation
 Empowerment Deck as a method to facilitate youth engagement at the National PPN
 Conference. Attended the Wicklow Youth Summit.

Networking/Working Regionally & Nationally

- PPN Conference: PPN National Conference 2023 took place on 5 & 6 Oct. 200 delegates from across the country represented PPN Secretariat & Reps, local authorities, local government reps and national government in the Arklow Bay Hotel. Presentations were provided on the National PPN Roadmap, the Westmeath Protocol. A social inclusion focused excursion took delegates to Beyond the Trees Avondale, while a community & voluntary focused excursion brought delegates to Aughrim Sports & Leisure Centre to meet many of the voluntary groups working in Aughrim. Environmental interest groups took a walk around Arklow to learn about coastal erosion, the wastewater treatment plant, and the harbour to headways project, while heritage interest groups had a guided tour of the Arklow maritime museum, the Abbey lane excavation site and mural and the Arklow castle, as well as finding out about Arklow's pyramid and pottery heritage. A community expo provided delegates with the opportunity to meet some of Wicklow PPN's member groups from across the county. Workshop topics included: Clare Anti-Poverty Strategy, Waterford Community Safety Partnership, Tipperary Community Climate Coaches, How we Network and Communications. Speeches, presentations, workshop materials and photographs are available on the PPN website.
- Dormant Accounts Funded Engagement Project Wicklow Local Community Development Committee (LCDC) was 1 of 4 LCDCs that received funding from this scheme. Wicklow PPN worked in partnership with WCC and Dr Harriet Emerson to identify and pilot engagement strategies that will encourage the participation of harder to reach communities in local planning & decision making. As a direct result of this work WCC produced a "Wicklow LECP Delivering for Communities from Policy to Action", a booklet that links the Local Economic & Community Plan to direct & visible development in the county. The new Social Inclusion Network Group was also developed as a sub-group of the LCDC. Wicklow's work was presented at the showcase event run by Pobal and the Dept Rural & Community Development in October and at the national Community & Voluntary Civic Forum meeting in November. It is also included in the new edition of "A Guide for Inclusive Community Engagement in Local Planning & Decision Making".
- PPN Communications & Publicity Campaign: Provided Wicklow Case Studies to be
 included in a national PPN Re-launch campaign. Wicklow was one of four PPNs who had
 projects included in the campaign, resulting in a delegation from Wicklow attending a
 Dept. Rural & Community Development (DRCD) photo shoot. DRCD, through Alice PR
 have devised a uniformity across PPN logos, developed a national PPN logo, and
 developed a PPN information animation. PPN promotional materials were launched
 across various local & national media platforms.
- **Minister of State Visit**: Joe O' Brien, Minister of State at the Dept. Rural & Community Development, and the Dept. of Social Protection with special responsibility for Community

- Development & Charities and the Dept. Children, Equality, Disability Integration & Youth with special responsibility for integration met with PPN Staff & Representatives in CEART, Wicklow Town 25/5. The minister showed particular interest in the PPN's hosting arrangement with Wicklow Travellers Group and how well it works.
- PPN Workers Network: Attended PPN Worker Meetings & linked with PPN Workers in
 other counties to provide peer learning, shared experience & support. Attended a 2-day
 retreat for PPN Workers in Athlone for training, peer support & networking. Collaborated
 with colleagues to submit a response to recommendations made in the National PPN
 Review.
- Southeast Regional PPN Network: Worked with PPN colleagues in Waterford, Wexford,
 Tipperary, Carlow, & Kilkenny to identify and collaborate on mutually beneficial projects
 including running a workshop with the Law Reform Commission to inform and hear
 members views on the consultation on the responsibility of unincorporated groups as well
 as supporting our PPN Representatives with training to help them be effective at local
 authority committee meetings.
- Irish Environmental Network: PPN Development Officer attended an Irish Environmental Network webinar on The Rights of Nature movement in Ireland. This meeting focused on the work of PPNs within this movement and included presentations from Clare, Tipperary, Galway, and Monaghan PPNs
- PPN National Advisory Group: Attend meetings as 1 of the 3 PPN Worker Representatives
 on this committee chaired by the Dept. Rural & Community Development. Also
 participated in Annual Report Sub-Group & Review Oversight Committee
- **PPN National Secretariat Network:** A Secretariat member attended regular meetings & participated in sub-groups of this peer support network.
- A representative from Wicklow Travellers Group (PPN Hosting Organisation) attended a
 Dept. Rural & Community Development webinar on the different forms of PPN hosting
 arrangements across the country 25 Oct. A recording of this session will be made available
 on the department's website.
- PPN National Housing Reps Network: Newly established in the autumn, this is expected to provide support & networking opportunities for PPN Reps that sit on local authority Housing Strategic Policy Committees

PPN Meetings/Specific Work

- Strategic Plan Development: A Strategic Plan sub-group of the Secretariat was formed, and a tender for support to develop the Plan was issued in March. Dr Harriet Emmerson was engaged. She issued a survey to member groups & other PPN Stakeholders in May. Results were shared with the PPN Secretariat & Representatives and a draft Strategic Plan was prepared which was adopted at the PPN Winter Plenary (members meeting)
- **Secretariat:** The Secretariat continued to advise and support the Resource Worker & Support Worker. Meetings were held in Jan, March, May, July, September and November along with Emails, texts and calls when further help was needed.
- Liaison Sub-Group: A group consisting of 1 rep each from the Secretariat, the hosting organisation and WCC along with the PPN Coordinator. The group ensures that all local PPN Stakeholders are informed of the PPN's development & progress. 2 meetings held
- PPN Policy Development: This subgroup of the Secretariat reviewed the PPN Constitution in relation to membership criteria, the Election Policy in relation to the voting process and Cyber Security Policies. The Service Level Agreements and Memoranda of Understanding for 2023 were finalised and signed by relevant parties.
- Summer Plenary (Members Meeting): 29 Wicklow PPN members attended the meeting held in The Avon in Blessington. Work reports & Financial Reports were presented and the meeting ratified new members, new Reps and revisions to our Constitution and Election

- Policy. Kim Townsend Smyth, the WCC Community Climate Action Officer gave a presentation on the upcoming Community Climate Action Fund.
- **PPN Annual Report:** The PPN Team (Secretariat, Representatives and PPN Workers) collaborated to complete the 2022 Annual Report. Over 80 questions sought information about; PPN membership; structures & networks; governance; representation; support; training; and events.
- Winter Plenary (Members meeting: 32 individuals representing 27 PPN member groups attended the meeting held in Arklow Presbyterian Church Hall. Work Report including finances, new members & new PPN Reps were presented and ratified. Wicklow PPN Strategic Plan for 2024-2029 presented and approved. Attendees also heard about the following funding schemes: LEADER (presentation from Alison Keogh, CWP) & the Community Climate Action Fund (presentation from Julie Sammiller, Wicklow Co. Co).
- **Governance**: Day to day correspondence, accounting, and reporting for PPN members, Secretariat, Host organisation, WCC and Dept. Rural & Community Development. Updating policies and procedures & running tendering processes where necessary.
- **Re-registration**: In line with both the PPN National Guidelines and our own Re-registration protocol we are required to undertake a formal Re-registration process with our member groups every three years
